Conditions of Entry

- 1. Categories and Presentation**
PRINTS: Three subject categories 'Abstract', 'Open Colour' and 'Open Monochrome'. 'Abstract' implies an image that retains the essence of the original concept, but has been altered, simplified, stylized or manipulated to result in a new form. No entry to the category will be excluded, but the judges will be asked to select on the basis of imaginative departure from literal representation.
 - Must be mounted on firm backing ready for exhibition and attached to the mount securely so that the print cannot become separated.
 - Prints must not be mounted on hardboard or heavy material that prevents the use of Velcro for hanging.
 - Minimum size of mat/mount 25cm x 30cm (10" x 12").
 - Maximum size of mat/mount 50cm x 40cm (20" x 16").
 - Maximum overall thickness is 1.25cm (1/2") and must be able to be stacked with other prints.
 - Each print must be clearly marked with the title (optional), entrant's name and address, and be numbered to correspond with the entry form (e.g. 2.3).
 - No framed or glass-mounted prints will be accepted.
 - **Entries that do not meet the above criteria will not be accepted.**
 - **Electronically generated patterns (e.g. fractals) are not permitted.****SLIDES:** Two subject categories 'Landscape' and 'Open'.
 - Must be spotted on the lower left corner when viewed normally, and be numbered to correspond with the entry form (e.g. 4.2). May be clearly marked with the title (optional).
 - The entrant's name and address must be on the back (not front).
 - Only slides contained with a 50cm x 50cm standard mount will be accepted.
 - Slides with glass over cardboard ready-mounts will not be accepted.
- 2. Eligibility**
 Entry acceptance is dependent on suitability to be handled without damage to other entries and at the discretion of the committee. Images that gained awards in previous Salons are ineligible.
- 3. Number**
 Entrants may submit up to four entries in each section (a maximum of 20 entries possible).
- 4. Fees**
 Entry fee is \$25.00 for one section and \$10.00 for each additional section entered. Please send the entry form and fee with your entries.
- 5. Process**
 The original image must be made by the entrant on photographic emulsion or acquired with a digital camera. Any modification of the image must be made by the entrant or under their personal direction. Trade processing is permitted for all sections. All components of the resultant image must be entirely the work of the entrant.
- 6. Liability**
 All possible care will be taken to safeguard entries. However, no responsibility will be accepted for any damage or loss to entries during transit or exhibition. It is the entrant's responsibility to ensure that the packaging is adequate to protect prints and slides.
- 7. Reproduction and Privacy**
 The right to reproduce entries for publicity or other purposes related to the North Shore National Salon of Photography is presumed unless specifically denied on the entry form. The right to make the entrant's name and address available to sponsors of the North Shore National Salon of Photography is presumed unless specifically denied on the entry form.
